#### **New Business**

The President met with the Executive Board members via a conference call. The meeting was called in reference to a matter of importance brought to her attention. Charmette Gloria Dorsett has been inactive for the past two fiscal years. It was brought to the President's attention in November's general meeting that Charmette Dorsett paid her dues for this fiscal year as well as her Cancer Project assessment. The President was not aware of this, and stated, although she paid her dues and assessments, she has not been in attendance to any meetings this fiscal year. In that meeting, it was suggested that the President contact Charmette Dorsett to find out what her intentions are and let her know that she is being missed.

The President sent Charmette Dorsett an email letting her know that her dues and assessment has been received and that she was missed by not attending the monthly meeting. However, the chapter look forward to seeing her in the upcoming December's meeting.

The President reported that Charmette Dorsett contacted her in reference to the email sent by the President. Charmette Dorsett stated that she is not prepared to return to active status at this time because of personal responsibilities. She requested additional inactive status. The President reported that she reminded Charmette Dorsett that the chapter's bylaws stated that a member can only be granted two years inactive status within a five year period and she has already been extended that time. The President stated that she discussed the probability of her monies being returned to her if she would not be returning, but could not promise her that it would be done. The President reported that Charmette Dorset stated that she did not know, that because she was not going to be active, that she did not have to pay dues. The President stated, Charmette Dorsett stated that she would donate the \$200.00 she paid for dues to the chapter to be used as they see fit, however, she did want the \$25.00 assessment for the Cancer Project to be used for that purpose.
